

Pupil Admission Number – consultation

The Academy Trust is now the admissions authority for the schools; we are committed to maintaining small, viable schools well into the future. Our schools are also increasingly being seen as schools that provide exceptional provision to our communities and that have caused pressure on our existing sites. We are therefore proposing increases in pupil admission number for a number of sites – we will never routinely have a class of over 30 and our average class size will be usually closer to 20.

Yoxford and Peasenhall Primary School: PAN to increase from 10 to 15

Mendham Primary School: PAN to increase from 7 to 10

St Edmund's Primary School, Hoxne: PAN to increase from 12 to 15

Technology is great when it works!

The Trust is investing significant amount of money in new technology and systems, most schools have had complete internal re-cabling, upgrades on Broadband supplier, new emails, new financial and management systems. Some schools are experiencing teething problems – please bear with us and if you are missing electronic communications contact you school office manager and they would be delighted to help you.

Severe weather procedures

Existing arrangements to deal with a school closure due to unforeseen issues of severe weather remain in place. The Academy Head will make the decision along with me whether a school is to close and parents will be advised as soon as possible. Website updates, text alerts and local radio stations. If a school is forced to close, staff will be redeployed to a neighbouring (or closest to their home) Trust school. Parents will be advised which Trust schools remain open and where pupils displaced from a closed school can attend (if it is safe to do so). It will always be our intention to keep our schools open, in the event of a closure an alternative provision may be offered.
